#### DATA PROTECTION DECLARATION

**This data protection declaration is an indispensable part of the application for membership.**

The personal data collected in the application for membership are used for the association's work and are stored and processed electronically by the ECG e.V. for the purpose of internal data and text processing. The legal basis is the BDSG (new), valid from May 25, 2018, and the DSGVO.

The following is collected and stored in detail:

1. First name, surname, gender (as indicated)
2. Address
3. Date of Birth
4. Phone number/mobile number
5. Bank details
6. E-mail address
7. In the case of partner memberships, corresponding partner data, which may allow conclusions to be drawn about sexual orientation.

The data is stored for the duration of membership in the member list. After termination of membership, the data will be stored in the club archive. This ensures that only the members of the Executive Committee have access to this archive.

The data is managed by Michael Sonneck - member administrator, Nordstraße 19, 40724 Hilden. Apart from him, the remaining members of the board, have access to this data.

**The processing is lawful because I give my consent to the processing of personal data concerning me for the following specific purposes:**

1. Collection of the membership fee
2. Mailing of the club magazine
3. Processing of the registration for club meetings, processing of club voting, Members' Favourite, service offers of the association, OGAE contests
4. Sending of information mails
5. Disclosure of surname, first name, membership number, date of birth, gender (as indicated), country, e-mail address and mobile number to the international umbrella organization OGAE International and the international provider when ordering tickets for the ESC and for the creation of an international membership card
6. Disclosure of surname, first name, e-mail address when ordering tickets for the German ESC national final

I hereby declare that I have voluntarily given my consent to the processing of my data for the above-mentioned purposes. I have been informed that I can withdraw my consent at any time. This does not affect the legality of the consent to the data processing that took place until the revocation.

I also declare that I agree to the activation of the members' area on the homepage and to the receipt of information emails.

I have the right to request the immediate deletion of the data I have collected if one of the following reasons applies (DSGVO, Art.17, Abs. 1):

1. My personal data are no longer necessary for the purposes for which they were collected or processed.
2. I revoke my consent on which the processing was based or there is no other legal basis.
3. I object to the processing.
4. The personal data have been unlawfully processed.

I have the right to request confirmation as to whether my personal data is being processed, namely about the purposes of the processing, the categories of my data being processed, the recipients to whom my data has been or will be disclosed, the planned duration of the processing or the criteria used to determine that duration.

I have the right to immediately request the correction of incorrect personal data concerning me. Taking into account the purposes of the processing, I have the right to request the completion of incomplete personal data - also by means of a supplementary declaration.

I have the right to lodge a complaint with a supervisory authority.

I hereby declare that I have read and understood the individual points of the data protection declaration. I accept all the points I have ticked. I am aware that full membership requires acceptance of the entire data protection declaration.
